RECYCLING SAVES RESOURCES BUT ONLY WHEN YOU DO IT RIGHT



OUR TRUCK UNLOADS

After collecting residential container recycling, our truck dumps the load at our facility for sorting. Unfortunately, because much of what you see here is not recyclable, this load is considered contaminated.

UNACCEPTED ITEMS

Bagged recyclables, clamshells, plastic bags, dirty containers, cartons and paper cups are not recoverable and go to the landfill.

ALL GO TO LANDFILL

Unacceptable items often make up a large portion of the material collected curbside. These are sorted out from the recyclables and go to the landfill.



ACCEPTED ITEMS

Accepted items in the container side of your cart include plastic bottles, milk jugs, clean glass jars and bottles and metal

TURN INTO FINISHED BALES

Clean recyclables such as these (left to

right) colored HDPE detergent bottles,

aluminum cans, and clear HDPE milk

bottles are baled and ready for recycling.

WHERE DOES IT GO, JOE?

MANAGING TREATED WOOD



During the pandemic, many of our customers found time to do projects around their home or back yard, leaving them on with a small or large pile of treated wood waste (TWW).

Until December 31 of 2020, through the alternative management standards (AMS), California hazardous waste laws granted exceptions to TWW generators, handlers, transporters, and landfills to dispose of the wood conveniently and affordably.

Since State regulators did not extend the AMS into 2021, starting January 1 of 2021, California requires TWW to be fully regulated as hazardous waste. Due to the regulatory changes, the Marin Resource Recovery Center (MRRC), also known as the indoor dump, can not accept TWW.

The good news is that the Department of Toxic Substances Control initiated a variances program as a temporary solution until new statutes are finalized. MRRC applied for a variance on February 19, 2021, and hopes to receive a permit to accept TWW at its facility in the following months.

We recommend you hold on removing any treated wood at your home or construction site if possible until April or May of 2021. If you don't know how to identify treated lumber, you can use some of the following tips:

- Hem and Douglas-Fir, Pines, and Spruce are some of the commonly treated woods
- Treated wood has an end tag that has information on the preservative applied to the wood and preferable sites to use the lumber (e.g., inside, outside, wet zones)
- Some of the chemicals applied to treated wood are arsenic, chromium, copper, creosote, and pentachlorophenol
- Look for different grades of green or brown staining on the wood
- Look for dents that look like staple prints throughout the wood

If you can not postpone the removal of any TWW, visit the DTSC website www.dtsc.ca.gov (or use the QR code to the left) and read the "Requirements for Generators of Treated Wood Waste Update-Fact Sheet (December 2020). The fact sheet offers all the steps to manage and dispose of TWW, including the disposal of the material at local household hazardous waste facilities. However, neither of the hazardous waste facilities in Marin County are accepting treated wood waste.
