AB 341: MANDATORY COMMERCIAL RECYCLING

IN 2012, CALIFORNIA ADOPTED AB 341 the Mandatory Commercial Recycling Measure to enhance systems that capture recyclable materials from the commercial sector. The purpose of the law is to reduce greenhouse gas emissions by diverting commercial solid waste from landfills and expand opportunities for recycling in California.

AB 341

Assembly Bill 341 requires multifamily complexes of five (5) or more units to recycle.

AB 1826: MANDATORY COMMERCIAL ORGANICS RECYCLING

REMOVING ORGANIC MATERIAL (compostables) from the landfill is not only a top priority for Marin Sanitary Service, it is an essential step toward achieving California's recycling and greenhouse gas emission goals. Not only does proper disposal of organic materials produce a soil amendment for California farmers, it also has an impact on reducing greenhouse gases. When organic material like food waste is landfilled, it breaks down anaerobically, creating methane and other greenhouse gases that leak from landfills and contribute to climate change.



AB 1826

Assembly Bill 1826 requires California multifamily complexes of five (5) units or more to recycle their organic waste depending on the amount of waste they generate per week.

The law's tiered implementation schedule phased in requirements over time based on the amount and type of organics or waste produced on a weekly basis.

JANUARY 1, 2017: Multifamily dwellings with 5 or more units that generate 4 cubic yards of organic waste (yard waste, nonhazardous wood waste, food waste and food soiled paper) per week must arrange for organic waste recycling services.

JANUARY 1, 2019: Multifamily dwellings with 5 or more units that generate four (4) cubic yards or more of waste and recyclables per week must arrange for organic waste recycling services.

January 1, 2021: Multifamily dwellings with 5 or more units that generate two (2) cubic yards or more of waste and recyclables per week must arrange for organic waste recycling services.

SB 1383: SHORT-LIVED CLIMATE POLLUTANTS (SLCP)

WHEN ORGANIC MATERIAL IS SENT TO LANDFILL, it breaks down without access to oxygen and creates methane gas. Landfills are the third largest source in the U.S. of human-caused methane – a potent heat-trapping gas that contributes to climate change. Senate Bill 1383 sets statewide targets to reduce disposal of compostable waste in our landfills. It also includes goals for the recovery of edible food.

SB 1383

Senate Bill 1383 sets statewide targets to significantly reduce the disposal of organic waste in landfill, and recover edible food.

SUBSCRIBE TO COMPOSTABLES SERVICE

Marin Sanitary Service offers garbage, recycling and compostables (as required by SB 1383) services. When service is set up, a multifamily dwelling recycling outreach coordinator will work with you to help set up the right services.



PROVIDE COLLECTION RECEPTACLES FOR YOUR TENANTS (WHERE APPLICABLE)



PROVIDE EDUCATION AND ENSURE TENANTS PARTICIPATE IN THE ORGANICS RECOVERY PROGRAM

- Annually provide information on the program to employees and customers.
- Ensure employees comply with the program.
- Where applicable, provide information on the organics recovery program to new tenants within 14 days of moving in.



PREVENT CONTAMINATION

SB 1383 has contamination requirements and requires that customers must not put any organic material in their landfill carts.
