MANDATORY CALIFORNIA RECYCLING & COMPOSTING



There are two important laws that impact businesses in California: SB 1383 the Mandatory Commercial Organics Recycling Law and AB 341 Mandatory Commercial Recycling Law. These laws are aimed at helping the state reach its diversion goals and to keep resources out of the landfill. MSS can work with your business to find the most economical way to become compliant under the laws.

AB 341: COMMERCIAL RECYCLING SB 1383: ORGANICS RECYCLING



Assembly Bill 341 requires California businesses, including public entities, and multifamily complexes of five (5) units or more that generate four (4) or more

cubic yards of solid waste per week to recycle. The purpose of the 2012 law is to reduce greenhouse gas emissions by diverting commercial solid waste from landfills and expand opportunities for recycling in California.

Subscribe to recycling programs such as containers, paper, and cardboard recycling.

Subscribe to an organics recycling service like the Food to Energy and/or commercial composting. Provide collection receptacles for your customers (where applicable). Provide education to ensure employees & customers participate in the organics recovery program. Prevent contamination. Customers must not put any organic material in their landfill carts or bins or compactor. Recover all edible food for donation.

FOOD 2 ENERGY

Food 2 Energy (F2E) is a unique program that diverts organic food waste from the landfill and into the energy grid. We pick up food waste from participating businesses and convert the material into a bio-gas through anaerobic digestion. That gas is then utilized as a power source for the Central Marin Sanitation Agency and helps power the operation of their sewage treatment facility.

HOW DOES YOUR BUSINESS PARTICIPATE?

If you are a large food waste generator such as a restaurant, assisted living facility, grocery store, school, hospital, or any other business or institutional facility that has food service you may qualify for the Food 2 Energy program.
